1. CALL TO ORDER:

Mayor Ortiz called the regular city council meeting to order at 7:00 pm; followed by the Pledge of Allegiance lead by Alderman Vera and Invocation by Alderman Bluemel.

2. CITIZENS TO BE HEARD:

There were no citizens to be heard.

3. CITY COUNCIL COMMENTS:

Alderman Frazier suggested that the dais be extended in length and moved away from the back wall. Several Alderman expressed thanks to the City employees for their continued hard work. The Mayor thanked the council for the last four years as Mayor. He was presented with a plaque and the incoming Mayor was presented with a new gavel.

After discussing it was concluded that Amy should attend the Natalia Municipal Development District meeting and request to use the MDD property for the festival as first choice location. No Action.
- 11. Discuss/consider action on Resolution No. 21-16; Designating authorized signers for all depository accounts with Security State Bank on behalf of the City of Natalia, Texas. Action: Alderman Frazier made a motion to pass resolution 21-16, Alderman Fernandez seconded the motion. Motion carried; 5-0 vote.
