1. CALL TO ORDER:

Mayor Bluemel called the regular city council meeting to order at 7:00 pm; followed by the Pledge of Allegiance lead by Alderman Vera and Invocation by Mayor Bluemel.

3. CITY COUNCIL COMMENTS:

Alderwoman Vera stated that the 18 wheelers continue to park by Love's & 135 access road. She also stated that there is still a pack of dogs roaming through the community. Alderwoman Vera requested a new police schedule and where gaps in coverage were.

Alderman Frazier asked what the status is with the dog issue at 471 & 5th Street. He stated that these dogs are dangerous dogs and need to be addressed.

Alderman Ortiz asked what the status is of the sprinkler system at the Veterans Monument. Nikki stated the MDD was supposed to get a quote to have the sprinkler system installed.

a) City Administrator/Secretary
