1. **Call To Order:** Roll Call (by Lisa Hernandez, City Administrator/Secretary)

No Council discussion or action may take place on a matter until such matter has been placed on an agenda and posted in accordance with law. 3. Discuss/Consider convening into Executive Session to deliberate on the following matters:
  - a) Review/Discuss/Consider legal issues and options related to the Natalia Police Department operations, protocols, and available options for the continued provision of law enforcement services.
4. **Executive Session:** The City Council may meet in Executive Session Pursuant to Section 551.074, Personnel Matters, and Section 551.071, Consultation with Attorney, of the Texas Government Code, to discuss the following:
  - a) Review/Discuss/Consider legal issues and options related to the Natalia Police Department operations, protocols, and available options for the continued provision of law enforcement services.
5. **Regular Session:** The City Council shall reconvene into Regular Session, and if necessary, may take action on items discussed in Executive Session.
6. **Presentation:** Presentation by the Medina County Sheriff's Department regarding available assistance with the continued provision of law enforcement services. Discussion with the City Council will follow the presentation.
7. **Discussion and possible action:** to authorize the Mayor and City Attorney to negotiate the final terms and conditions of a possible contract or interlocal agreement to secure the continued provision of law enforcement services as discussed and directed by the City Council.
