Dear Sir/Madam:

This letter is to inform you that the City of Natalia, Texas implements a health and sanitation program, and contracts the Health & Sanitation Inspections with Environmental Health Group (EHG). Health Sanitarian Rebecca Vera is the inspector assigned to the City of Natalia. You may contact EHG with any questions you may have regarding food health sanitation and safety requirements by phone at (210) 257-6975, or by emailing: rebecca@ehgtx.net.

Additionally, each food establishment is required to obtain a food establishment permit on an annual basis, and premises will be inspected a minimum to two times per year; these biannual inspections do not include any complaint driven or follow-up inspections performed by the Sanitarian Inspector.

The annual health permit inspection fee is \$200.00, and each complaint driven or follow-up is an additional \$85.00 per inspection, all costs are incurred by the food establishment.

If you have failed any part of your routine health inspection, follow-up inspections may be required and any costs will be billed to your establishment. Failure to pay may result in disconnection of utility services. It is important that you provide a clean, safe and healthy environment to your customers, and to avoid any noncompliant violations.

Please be sure keep your food establishment permit is up to date; if your permit is expired, this may result in termination of your services. Should you need to renew your permit, please email CityAdmin@cityofnatalia.com and an application will be forwarded to you. Hours of operation are 8:00 am to 4:30 pm, Monday through Friday, excluding holidays.
