The Natalia Police Department has adopted a detailed written policy on racial profiling.

**Our Policy:**

1. Clearly defines acts constituting racial profiling;
2. Strictly prohibits peace officers employed by the City of Natalia from engaging in racial profiling
3. Implements a process by which an individual may file a complaint with the Natalia Police Department if the individual believes that a peace officer employed by the City of Natalia has engaged in racial profiling with respect to the individual;
4. Provides public education relating to the agency's complaint process;
5. Requires appropriate corrective action to be taken against a peace officer employed by

The City of Natalia who, after an investigation, is shown to have engaged in Racial

Profiling in violation of the Racial Profiling Policy;

6. Requires collection of information relating to motor vehicle stops in which a citation is issued and to arrests made as a result of those stops, including information relating to;

- a) The race or ethnicity of the individual detained;
- b) whether a search was conducted and, if so, whether the individual detained consented
  - c) to the search;
- d) whether the peace officer know the race or ethnicity of the individual detained before
  - e) detaining that individual;
- f) whether the peace officer used physical force that resulted in bodily injury during the
  - g) stop;
  - h) the location of the stop;
  - i) the reason for the stop;

7. requires the Chief Administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under

Subdivision (6) to:

- a) the Commission on Law Enforcement; and
- b) the governing body of each county or municipality served by the agency, if the agency is
  - c) an agency of a county, municipality, or other political subdivision of the state.

The Natalia Police Department has satisfied the statutory data audit requirements as prescribed in Article 2.133(c), Code of Criminal Procedure during the reporting period.
