### **EXECUTIVE SESSION**

The City Council will meet in closed session pursuant to Government Code Section 551.071 to consult with its legal counsel on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter; to wit: legal questions regarding the appropriate procedures for the handling of personnel complaints and the duties and responsibilities of those involved.

The City Council will meet in closed session pursuant to Government Code Section 551.074, personnel; to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee, or to hear a complaint or charge against an officer or employee; to wit: the Chief of Police. The employee may request that all deliberation take place in the public meeting.
5. The City Council will meet in closed session pursuant to Government Code Section 551.074, personnel; to deliberate the duties of a public officer; to wit: the duties of the Mayor. The Mayor may request that all deliberation take place in the public meeting.

6. The City Council shall reconvene into Regular Session, and if necessary, may take action on items discussed in Executive Session


